Research Interests:

- (1) Social psychology of ability evaluation (interpersonal processes involving expectations, evaluations, and performances), in particular:
 - (i) Status, influence, and rewards in task groups,
- (ii) Group prejudices and stereotypes (especially those based on gender, ethnicity, and native-born/immigrant),
- (iii) Standards, social comparisons, and the assignment of task competence, and
- (iv) Actors' and observers' reactions (cognitive and affective) to success and failure.

Development of formal theoretical models for these processes, and experimental tests in small group contexts. Applications to work settings: hiring and promotion decisions; performance evaluation; salary allocations.

(2) Theoretical and methodological issues in cross-cultural experimental social psychology.
